Partial Answer. This is what makes me glad that this column is running and our members are using it. I looked in a book, given to us by Evelyn Perry of Lincoln County, called At Rest in Lincoln County. On page 20, at the end of the Elk City Cemetery entry, is this small entry.

> "Earlier cemetery at Elk City was on hill above home of Bob Parks today. That area was surveyed into streets and above was ball grounds. From memory of older residents I give these few burials:" Here she lists five people.

This book was published in 1979, so all you need to do to start is check where Bob Parks lived in 1979. I think that I would start at the assessors office in Lincoln County.

To those new members that don't know, during our formative years, part of Lincoln county was Benton county.

(2) Does anyone know where Fruitvale or Fruitvale Cemetery is? In working with the GT Indexing, I ran across this name and can't find it. The time period was about 1890, and probably somewhere in Benton county. Ed Stratton.


LIBRARY

Mrs. Jans greeted Edna Wiese and I with a bright smile and a cherry "Hello". She was dressed in a beautiful red blouse with tiny ruffles down the front and around the neck complemented by a warm plaid skirt.

She is one of our charter members and has researched her family of **TROUSDALE** back for six generations. They came from Ireland in the 1700's as indentured servants and landed in Maryland, later settling in Ohio, Wisconsin, and Colorado.

Mrs. Jans was born July 25, 1897. Her husband Fred worked for the Department of Agriculture as special extension agent for the western states. They lived in Silver Springs, Maryland where their two sons and two daughters were born. He retired after thirty-five years and they moved to Oregon in 1958.



SCHWEITZER SEMINAR

I was among the 120 people gathered at the Mill Creek Inn in Salem on Saturday, April 25, for a day-long seminar with Dr. George K. Schweitzer. By the end of the afternoon I felt my \$25 registration fee was a great bargain for the privilege of spending a delightful day being entertained and informed by Dr. Schweitzer plus a very edible box lunch.

His three lecture subjects were The War of 1812 Genealogy, Tracing Your Ancestors Back Across the Atlantic, and Tennessee Genealogical Research. Unhappily the costumes that he planned to wear to illustrate his talks -- War of 1812 uniform, Bavarian lederhosen, and backwoodsman's hunting shirt and coonskin cap -- did not get transferred when he was forced to change planes. "The got left on the United wagon train," he said. Nevertheless, he made history come alive. I understand something of what the War of 1812 accomplished, and I have a better idea of the reason for certain immigration routes.

We sat at tables comfortable for taking notes, and were given excellent legal-length, single-spaced outlines of each talk. Dr.. Schweitzer whisked up and down the aisles, keeping us in a ripple of laughter.

One piece of general advice was: "Don't make up reasons not to look at records."

By the end of lunch period all his books had been sold out.

FAGAN: HISTORY OF BENTON COUNTY, OREGON BIOGRAPHIES 1885

STEWART, James H. -- was born in Fountain county, Indiana, 19 June 1823, and there resided until 19 years of age. His parents then moved to Polk county, Missouri, where he followed farming until 1851, when he, with his mother, wife and 2 children, came across the plains to Oregon, arriving in Corvallis 28 September of that year. A few months later he took up as a donation claim the farm where he now resides, 2 miles north of Corvallis.

STEWART, John -- (deceased) -- the well-known and highly respected citizen of 40 years residence in Benton county, was born in Knox county, Virginia, on 12 February 1799 and died at his home near Corvallis in February 1885. When he was quite young his parents moved to Indiana and, in 1842, to Missouri. In 1845 our subject joined a train, of which he was elected captain, and came across the plains to Oregon. In this train were many of the prominent citizens of Benton county. Mr. STEWART on his arrival in Benton county in the spring of 1846 located on the place where he died, consisting of 640 acres.

STEVENS, William -- a resident of Caledonia, Benton county, Oregon, was born in Stuben, Maine, 8 April 1810, and came west to Wisconsin in 1847, and arrived in Benton county, Oregon 16 December 1873, and has since followed farming. Mr. STEVENS was married to Miss Anna LEIGHTON in Stuben, Maine, 20 March 1834. They have 5 children: Judith (now Mrs. H. W. VINCENT), Lucy, George, Mary A., and Mary L.

STOUT, W. B. -- is Justice of the Peace and Notary Public of the city of Newport, Yaquina Bay, and is a gentleman of high standing in the community where he resides. Mr. STOUT was born in Tazewell county, Illinois, 29 March 1853, and arrived in Oregon 9 September 1861 and came to Benton county in October 1876, at that time taking up his residence in Newport, where he now lives. Mr. STOUT was united in marriage in Linn county, Oregon 8 November 1868, to Miss Mary J. McFADDEN, a native of Linn county. By this union they have a family of 5 children, viz: Anna M., Hannah E., Laura W., Etta M., and Claude M.

THOMPSON, Joseph -- the subject of this sketch was born in Huntington county, (now Blair county) Pennsylvania, in 1832, and there resided until 1852, in the mean time learning the printer's trade. In the spring of the above year he joined what was known as Morrison's Train, at Dubuque, Iowa, to cross the plains to Oregon, coming all right until they reached Tule Lake, there they were surprised by a band of 150 Modoc Indians, and when after a desperate fight, with the loss of 2 guides and one packer killed, and our subject wounded, they were finally rescued by a party from Yreka. Mr. **THOMPSON** on his arrival at Yreka began mining for a short time and then went to Sacramento and San Francisco, where he worked at this trade, and at one time published a paper at Nevada City. In 1869, he came to Oregon, and direct to Yaquina Bay, and located on his present farm of 160 acres adjoining the new town of Caledonia, and one mile from Toledo, where he has

since made his home, but spent most of the time working at his trade on the daily papers of Portland. Mr. **THOMPSON** was married in Nevada City, California, to Miss M. V. **HERBERT** -- they have 5 children, viz: Morris, Daisy, Joseph, Lillie, and Harriet.

VAN CLEVE, Collins -- was born in Morgan county, Illinois, 26 August 1833. His father Dr. John VAN CLEVE, was an eminent minister of the Methodist denomination, consequently, owing to the many changes the ministers of that faith are subject to, Coll. lived in several different places until he was 9 years of age, when he quit the parental roof, since which time he has done for himself. At the age of 14 he started to learn the printer's trade, which he followed until the breaking out of the war. On the first call being made in 1860, our subject was then running a newspaper in Bellville, Illinois. He immediately began the organization of a company, with which he served until 1862, when he was discharged on account of sickness. He then, on regaining his health, started west to Fort Benton; thence to Lewiston, Idaho, where he published a paper for a time, and finally came to Portland where he worked on the "Oregonian" and the "Portland Times". In 1868 Mr. VAN CLEVE came to Albany, Linn county, where he founded the "Albany Register", which he continued to edit until 1882, when he was appointed Custom's Collector for the Yaquina District with his office at Yaquina City, where he also in the latter year started his paper the 'Yaquina Post." Mr. VAN CLEVE was at one time Mayor of Albany. He is married, and has 6 children.

VAN BEBER, Lazarus -- among the many pioneers of Benton county, there are none more highly respected that this early argonaut of King's Valley, having arrived in that beautiful place where the whole valley lay in it virginity and the feet of white man had hardly tread upon it -- his was among the first to press it. Mr. VAN BEBER was born in Clayborn county, Tennessee, 27 February 1807. At the age of 21 years he emigrated to Illinois, where he followed farming until the spring of 1846, when, with his family and mule teams, he crossed the plains to Oregon, and to Benton county, taking up his donation claim in King's Valley, where Morris ALLEN now lives. He now owns a farm of 350 acres in the south end of the valley where he now resides.

VINCENT, H. W. -- a merchant and mill owner of Caledonia, on Yaquina Bay, was born in Watertown, New York, 1 April 1832. In 1851 he moved to Wisconsin and, 3 July 1874 arrived in Benton county, Oregon and first located in Corvallis, when a few years ago he moved to Yaquina Bay, and in 1885, founded the town of Caledonia, where he now resides. Mr. VINCENT was married in Ripon, Wisconsin, 31 October 1865, to Miss Judith STEVENS, a native of Gouldsborough, Maine. Their children are Frank, Fred and Georgia.
